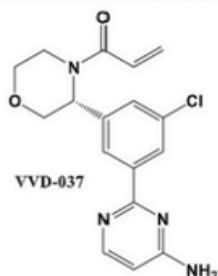

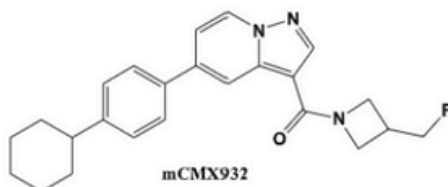

THE 26th ANNUAL SAN DIEGO MEDICINAL CHEMISTRY SYMPOSIUM

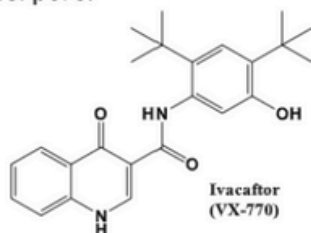
The 26th Annual San Diego Medicinal Chemistry Symposium took place on July 11th at UC San Diego. Hojel Hall in the Institute of the Americas was filled with over 300 attendees who came to hear talks from an outstanding set of local speakers. This year, the opening talk by Dr. David Weinstein from Vividion Therapeutics described the use of quantitative chemoproteomic to identify VVD-037 as KEAP1 activator for the treatment of NRF2-activated solid tumors.



Next, Associate Professor Michael Bollong from Scripps spoke about using small molecules as regenerative medicines. Their discovery of an agonist of the YAP:TEAD transcriptional complex, specifically, mCMX932, could lead to a new treatment for heart failure by reversing heart muscle damage. Compound mCMV852 is currently undergoing preclinical studies.



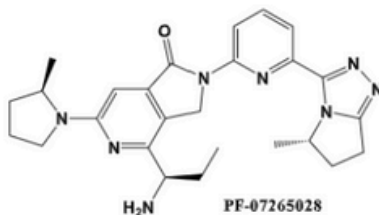
To complete the morning session, Dr. Jinglan Zhou from Vertex Pharmaceuticals elaborated on her group's discovery of Ivacaftor (VX-770), a "potentiator" of CFTR, meaning it increases the probability that the defective channel will be open and allow chloride ions pass through the channel pore.



She showed how combinations of "potentiator" Ivacaftor can be combined with CFTR "correctors", specifically lumacaftor or tezacaftor to treat nearly 50% of cystic fibrosis patients. The addition of another "corrector", elxacaftor to the combo can now treat 90% of cystic fibrosis patients.

After the coffee break, Professor Elizabeth Winzeler from UC San Diego presented on her group's use of genetics to discover how malaria drugs work and which targets are conserved across parasitic species. Her work with the Malaria Drug Accelerator (MaIDA) has helped to identify new targets and early chemical leads for the global malaria drug discovery pipeline.

Dr. Joyann Donaldson from Pfizer delivered the final lecture of the day, presenting on the design of HPK1 small molecule inhibitor PF-07265028. Her talk included the development of novel routes to fused triazoles and chiral amino methylation methodology.

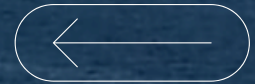

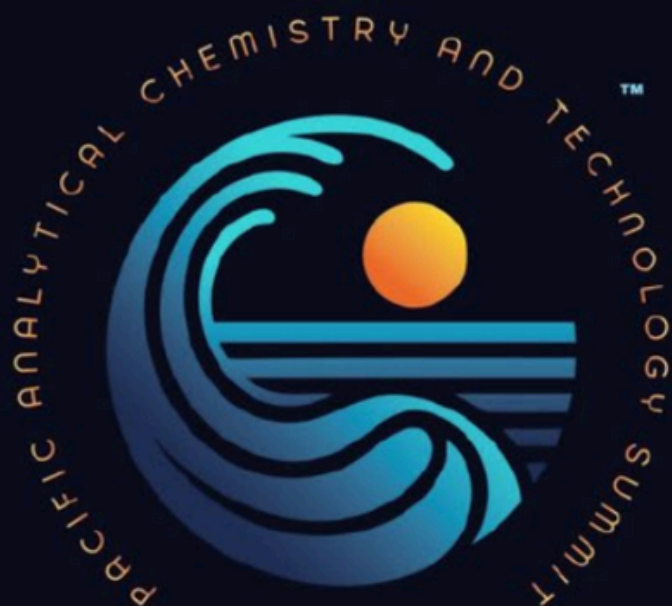

Changes/Approval of May Minutes

Motion #1: Approve May 2025 Minutes — M/S/P Approved with 1 abstention

Treasurer Report

Treasurer Desiree Grubisha was unable to attend this evening, but reported that two sponsorships came in for the MedChem Symposium. No other transactions beyond regular monthly expenses.

Recap Meetings

Dr. Matthew Kromer gave a virtual talk on May 27, 2025 on Wildfire Chemistry and its effects soil and air and the relevance to firefighters and to society. With the notice coming a bit late as we set up what was happening for May, we were happy to have 22 in attendance out of the 36 who registered.

Future Meetings

Dr. Nicholas Meanwell will be doing a reboot of his talk on Inhibitors of HIV-1 Attachment on June 19, 2025 at 6pm. The previous session was unfortunately cut short due to technical difficulties, but Dr. Meanwell has graciously agreed to return.

July will be the MedChem Symposium and possibly the 50-year Luncheon, so we will look for an August speaker.

WD-40 can do virtual anytime, but in-person would be best in October or March when more chemists are on the west coast. They invented WD-40 here and still have a small presence of chemists, but the actual R&D is in New Jersey now. They still do a lot of chemical problem-solving in San Diego, but it is not as interesting. We want R&D Chemists for their stories and what's coming in their field. In Person with samples would draw more outside interest. Ask for March in person or August virtual or in October if the Distinguished Scientist/Awards Banquet is moved.

Blue Nalu – September Discussing with their PR folks to try to get a protein chemist.

Jiyue is working on a possible August event as well.
